I understand and acknowledge that by checking the box below, or signing this document, I am legally agreeing to all of the statements in it, in exchange for being permitted to participate in 8th Annual Grafenwoehr Rugged Terrain Obstacle Run on April 23, 2022 at the Tower Barracks Physical Fitness Center, Bldg 170, USAG Bavaria, APO AE, 09114.

1. I understand and recognize that participation in the Grafenwoehr Rugged Terrain Obstacle Run is a hazardous activity, which is inherently dangerous. It is a test of my physical and mental limits where physical or mental injury cannot be completely eliminated.
